Seeking an escape from life in her small village in Japan, Hana Omiya arrives in California in 1917, one of thousands of Japanese "picture brides" whose arranged marriages brought them to the United States. When she finally sets foot on a pier in San Francisco, she is disappointed to meet her soon-to-be husband, the stoic Taro Takeda, who looks much older than in the photo his family had shared. Far from the fantasy life she dreamed up back home, Hana confronts emotional distance from her husband and hostility from white neighbors,

eventually focusing her energy to support others in her tight-knit community. Showing the complexity of Issei life, Hana's story is intertwined with the stories of others: her best friend Kiku and Kiku's husband Henry, who reject demeaning city work to become farmers; Reverend Okada, a community leader who eventually decides to return to Japan; and Hana's daughter, Mary, who rejects her family and runs away with her boyfriend. Ultimately, as Japanese Americans are evacuated from their homes and imprisoned in concentration camps, we see how Hana and others cope with the heartache of losing everything they worked hard to build.



From the mid-1950s to the mid-1970s, Japan experienced an unprecedented level of economic growth, transforming itself from a wardevastated country to a global economic power. Our image of postwar Japan has been shaped by this event, and we tend to see its history as a story of great national success. *Cinema of Discontent* challenges this view and details the tensions generated by massive and intense capitalist development through analyses of popular cinema produced during the era of high-speed growth. The films discussed in this

book, directed by Kawashima Yūzō, Masumura Yasuzō, Inoue Akira, Ezaki Mio, and Kumashiro Tatsumi, attracted broad audiences yet remain understudied. *Cinema of Discontent* contextualizes these films in relation to the politics, economy, intellectual discourse, and cultural texts of the time.





Mordecai Kurz develops a comprehensive integrated theory of the dynamics of market power and income inequality. He shows that technological innovations are not simply sources of growth and progress: they sow the seeds of market power. In a free market economy with intellectual property rights, firms' control over technology enables them to expand, attain monopoly power, and earn exorbitant profits. Competition among innovators does not eliminate market power because technological competition is different from standard competition;

it results in only one or two winners. Kurz provides a pioneering analysis grounded on quantifying technological market power and its effects on inequality, innovation, and economic growth. He outlines what causes market power to rise and fall and details its macroeconomic and distributional consequences.

Drawing on economic and historical analysis as well as his extensive experience in government and philanthropy, he examines the failures of public policy and conventional economic wisdom that have led to the neglect of American cities and highlights opportunities for reform. Unequal Cities features detailed case studies of New York, Detroit, and Los Angeles, tracing how their attempts to achieve greater equity foundered

because of the fiscal and political constraints imposed on them. McGahey identifies key lessons about the political coalitions that can overcome anti-urban biases, arguing that alliances among unions, environmentalists, and communities of color can help cities thrive. But he warns that cities cannot solve inequality on their own: political action at state and federal levels is necessary to achieve systemic change.

Drawing evidence from first-hand interviews, an original survey of anti-Brexit activists, and an analysis of their campaign materials, Fagan and van Kessel conclude that while the anti-Brexit movement was successful in mobilizing a large number of pro-European citizens, its impact was limited by weak links to political elites and institutions, divisions between organizations and activists, and the absence of a clear stance on the UK's relationship with the European Union.







Kenneth Janda sheds new light on the Republican Party's transformations, drawing on a wide range of quantitative and qualitative evidence. He examines nearly three thousand planks from every Republican platform since 1856 as well as candidate statements and historical sources, tracing the evolution of the party's positions on topics such as states' rights, trade, taxation, regulation, law and order, immigration, environmental protection, and voting rights. Janda argues that the GOP has gone through three main phases over the course of its history, transforming from a party committed to governance to one vehemently opposed to government.

It is widely believed that shifts in the balance of power between an established hegemon and a rising upstart can lead to war. To what extent does this proposition hold true for Sino-American relations today? Steve Chan examines a range of international relations theories and popular narratives that suggest an elevated risk of confrontation between the two powers. Probing the recent deterioration in Sino-American relations, he considers whether several factors that can raise or lower international tension apply to the current situation. Chan demonstrates

that power shifts do not preordain violent outcomes - nor does their absence ensure peace. Criticizing overly mechanistic frameworks, he emphasizes that domestic politics, international political economy, and the choices of individual leaders are all crucial to understanding why wars happen.

Scott L. Kastner offers a comprehensive analytical account of PRC-Taiwan relations that sheds new light on the prospects for crossstrait military conflict. He examines several key regional trends that have complex implications for stability, including deepening economic integration, the shifting balance of military power, uncertainty about the future of U.S. commitment, and domestic political changes in both the PRC and Taiwan. Kastner argues that the risks of conflict are real but should not be exaggerated. Several distinct pathways could lead to the

breakout of hostilities, and the mechanisms that might allay one type of conflict do not necessarily apply to others - yet war is anything but inevitable. Although changes to the balance of power introduce risks, powerful mitigating factors remain in place and there are plausible steps to reduce the likelihood of military conflict.

The proliferation of sanctions spurs efforts to evade them, as states and firms seek ways to circumvent U.S. penalties. This is only part of the story. Sanctions also reshape relations between countries, pushing governments that are at odds with the U.S. closer to each other - or, increasingly, to Russia and China.





Drawing on the work of Max Scheler, Maurice Merleau-Ponty, and critical feminist phenomenology, Butler illuminates the conditions in which we seek to make sense of our disorientation, precarity, and social bonds. *What World Is This?* offers a new account of interdependency in which touching and breathing, capacities that amid a viral outbreak can threaten

life itself, challenge the boundaries of the body and selfhood. Criticizing notions of unlimited personal liberty and the killing forces of racism, sexism, and classism, this book suggests that the pandemic illuminates the potential of shared vulnerabilities as well as the injustice of pervasive inequalities.





Conjuring the Buddha offers a history of early tantric Buddhist ritual through the lens of the Tibetan manuscripts discovered near Dunhuang on the ancient Silk Road. Jacob P. Dalton argues that the spread of ritual manuals offered Buddhists an extracanonical literary form through which to engage with their tradition in new and locally specific ways. He suggests that ritual manuals were the literary precursors to the tantras, crucial to the emergence of esoteric Buddhism. Examining a series of ninth- and tenth-century tantric manuals from Dunhuang,

Dalton uncovers lost moments in the development of rituals such as consecration, possession, sexual yoga, the Great Perfection, and the subtle body practices of the winds and channels.

What, if anything, is Esoteric Pure Land Buddhism? In 1224, the medieval Japanese scholar-monk Döhan (1179-1252) composed *The Compendium on Esoteric Mindfulness of Buddha (Himitsu nenbutsu shō)*, which begins with another seemingly simple question: Why is it that practitioners of mantra and meditation rely on the recitation of the name of the Buddha Amitābha? To answer this question, Döhan explored diverse areas of study spanning the whole of the East Asian Mahayana Buddhist tradition. Although contemporary scholars often study

Brian Nichols's pioneering book, *Lotus Blossoms and Purple Clouds*, centers on a large Buddhist monastery in Quanzhou and combines ethnographic detail with stimulating analysis to examine religion in post-Mao China. Nichols conducted more than twenty-six months of field research over a fourteen-year period (2005-2019) to develop a re-description of Chinese monastic Buddhism that reaches beyond canonical sources and master

narratives to local texts, material culture, oral history, and living traditions. His work decenters normative accounts and sheds light on how Buddhism is lived and practiced.

Before the twentieth century, Japanese religious and cultural life was shaped by a variety of yearly ceremonies, festivals, and customs. These annual events (nenju gyoji) included Shinto festivals in which participants danced through the night to boisterous music and Buddhist temple practices that honored deities, great priests, or temple founders with solemn rituals and prayers - and sometimes, when the Buddha

was invoked, raucous dancing. Temples also hosted popular fairs, where holy objects and artwork were displayed to the faithful and curious. Countless other celebrations were held annually at the residences of the nobility and military elite and at commoner domiciles. Kyoto, the imperial - and cultural - capital since the eighth century, was the center of many of these events. From Kyoto festivals, rituals, and celebrations diffused to other parts of the land, ultimately shaping religious, artistic, and everyday life as a whole. By the seventeenth century the Kyoto public wished to inform itself more accurately about nenju gyoji and their dates and meanings. As a result, a growing number of guidebooks and almanacs were written and published for the urban populace.




