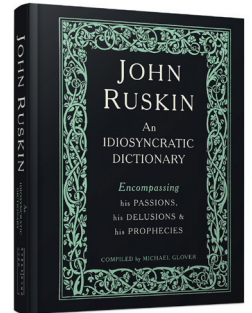

When off his guard, Ruskin could write pithily and amusingly, but he was also a fascinating amalgam of self-contradictions. Combining judiciously selected extracts from Ruskin's writings with the author's wittily insightful interpretations, this book is essential reading for all those curious to know what Ruskin did with a cyanometer, why he hated iron railings and the Renaissance, and how Proust's admiration of the man was tinged with distrust.

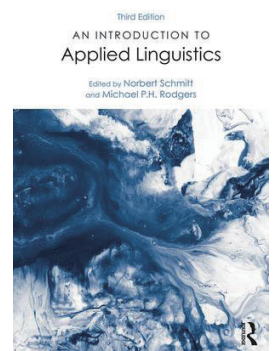

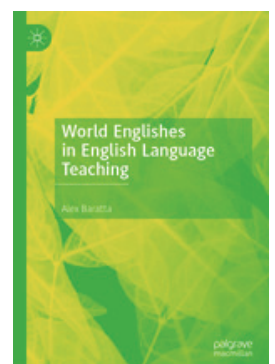

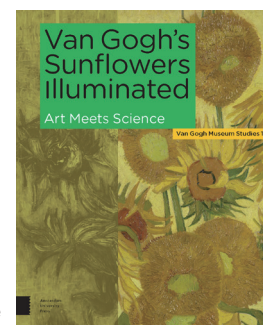

Vincent van Gogh's *Sunflowers* are seen by many as icons of Western European art. Two of these masterpieces - the first version painted in August 1888 (The National Gallery, London) and the painting made after it in January 1889 (Van Gogh Museum, Amsterdam) - have been the subject of a detailed comparison by an interdisciplinary team of experts. The pictures were examined in unprecedented depth using a broad array of techniques, including state-of-the-art, non-invasive imaging analytical methods, to look closely at and under the paint surface. Not only the making, but also the subsequent history of the works was reconstructed, including later campaigns of restoration. The study's conclusions are set out in this book, along with the fascinating genesis of the paintings and the sunflower's special significance to Van Gogh.

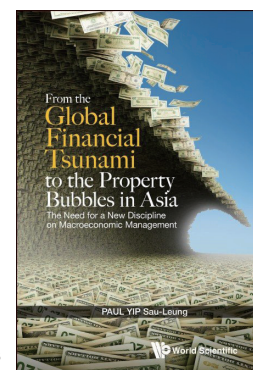

If properly done, these would help pre-empt financial crises, currency crises and asset bubbles in the future.

Using a qualitative approach, including over 150 interviews with Japanese and Chinese business and industry leaders, combined with statistical analysis of unique firm-level data, this book brings a 'firm-level view' to this crucial case of political conflict amid economic interdependence. It argues that there is wide variation in the degree of material damages Japanese multinationals sustain in the aftermath of political disputes, and how threatening they perceive the risks of political conflict to be. This book then goes on to evaluate the different responses to risk, from promoting Japan's culture through privately funded tactics and building common cause with the government, to diversifying a portion of assets abroad and even leaving China entirely.

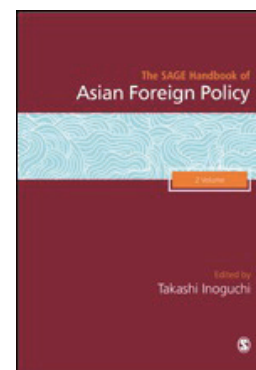

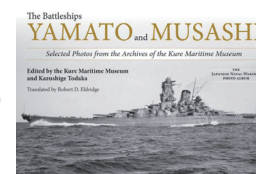

Originally published in Japan in 2005, each album in the Japanese Naval Warship photo album series contains official photographs taken by the Kure Maritime Museum, as well as those taken by private individuals. These pictorial records document the main types of Japanese vessels, from battleships to submarines, based on the best images from Shizuo Fukui, a former Imperial Japanese Navy commander and technician. These photos include the ones Fukui began collecting as a young boy and continued to do after he began work as a naval shipbuilder, and those that he was given in order to complete a photographic history of the Imperial Japanese Navy's ships. The latter included images gathered by Nagamura Kiyoshi, a shipbuilder who proactively collected photos, and from the collection of machinist Amari Yoshiyuki. Moreover, with the help of shipbuilder Makino Shigeru, among others, Fukui was able to continue gathering photographs and other items throughout the postwar period.

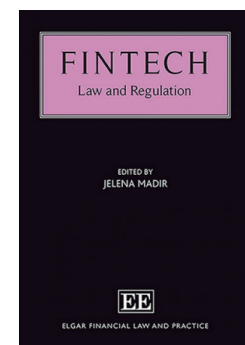

Though there has been much discussion on the academic aspects of Japanese education abroad (e.g., high scores on international tests, lesson study), there has been little information on the non-academic aspects of Japanese schooling. The non-academic aspect is called *Tokkatsu* (tokubetsu katsudo). Compared to math and reading, it does not occur during a certain hour of the day, and rather extends throughout the day, and to hours outside of the regular classrooms - such as school excursions. It includes classroom activities such as classroom discussions, morning and afternoon meetings that take place daily, cleaning and serving lunch, school events such as sports day, school excursions, student councils, and club activities. Such activities occur every single day, throughout one's school years, from elementary school (actually, even kindergarten) to high school. They are, however, bound together by the common goals of the Tokkatsu framework.

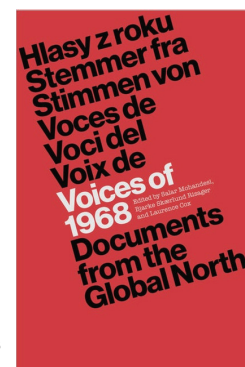

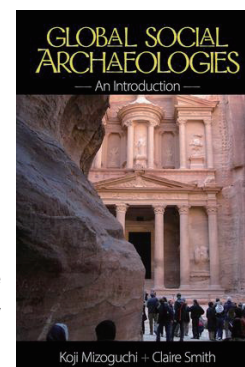

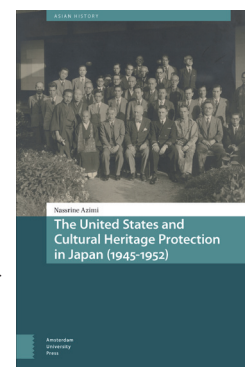

One of the untold stories of the American military occupation of Japan, from 1945 to 1952, is that of efforts by the Supreme Commander for the Allied Power's (SCAP) Arts and Monuments Division for the preservation of Japan's cultural heritage. While the role of Allies after WWII in salvaging the cultural heritage of Europe has recently become better known, not much is written of the extraordinary vision, planning and endeavors by the curators and art specialists embedded in the US military and later based in Tokyo, and their peers and political masters back in Washington D.C. -all of whom ensured that defeated Japan's cultural heritage was protected in the chaos and misery of post-war years.
