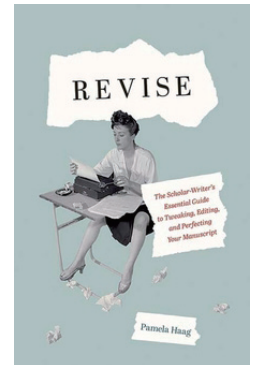

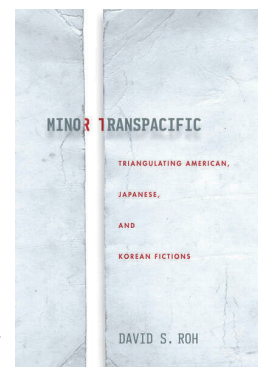

There is a tendency to think of Korean American literature - and Asian American literature writ large - as a field of study involving only two spaces, the United States and Korea, with the same being true in Asian studies of Korean Japanese (*Zainichi*) literature involving only Japan and Korea. This book posits that both fields have to account for three spaces: Korean American literature has to grapple with the legacy of Japanese imperialism in the United States, and *Zainichi* literature must account for American interventions in Japan. Comparing Korean American authors such as Younghill Kang, Chang-rae Lee, Ronyoung Kim, and Min Jin Lee with *Zainichi* authors such as Kaneshiro Kazuki, Yi Yang-ji, and Kim Masumi, *Minor Transpacific* uncovers their hidden dialogue and imperial concordances, revealing the trajectory and impact of both bodies of work.

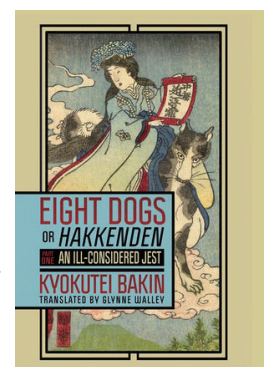

Kyokutei Bakin's *Nansō Satomi hakkenden* is one of the monuments of Japanese literature. This multigenerational samurai saga was one of the most popular and influential books of the nineteenth century and has been adapted many times into film, television, fiction, and comics. *An Ill-Considered Jest*, the first part of *Hakkenden*, tells the story of the Satomi clan patriarch Yoshizane and his daughter Princess Fuse. An ill-advised comment forces Yoshizane to betroth his daughter to the family dog, creating a supernatural union that ultimately produces the Eight Dog Warriors. Princess Fuse's heroic and tragic sacrifice, and her strength, intelligence, and self-determination throughout, render her an immortal character within Japanese fiction.

Don't Follow the Wind は、福島原発事故帰宅困難区域で2015年から開催されている展覧会

The twelfth volume of the Critical Spatial Practices series focuses on "Don't Follow the Wind," the acclaimed collaborative project situated in Fukushima's radioactive exclusion zone. The book explores the long-term environmental crisis in the coastal Japanese region through this ongoing, inaccessible exhibition, which maintains traces of human presence amid the fallout of the March 2011 nuclear reactor meltdown that displaced entire towns. What can art do in a continuing catastrophe when destruction and contamination have made living impossible? The exhibition is located inside the exclusion zone, an evacuated radioactive area established after the nuclear disaster that forcibly separated residents from their homes, land, and community. In cooperation with former residents, participating artists installed newly commissioned works at sites in the exclusion zone. Although the exhibition opened in March 2015, the zone is still inaccessible to the public - the exhibition, like the radiation, is virtually invisible. The exhibition can only be viewed when restrictions are lifted and people are permitted to return.

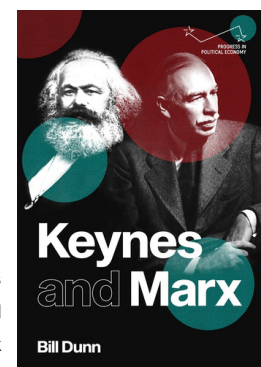

Keynes was an elitist and pro-capitalist economist, whom the left should embrace with caution. But his analysis provides a concreteness missing from Marx and engages with critical issues of the modern world that Marx could not have foreseen. This book argues that a critical Marxist engagement can simultaneously increase the power of Keynes's insight and enrich Marxism. To understand Keynes, whose work is liberally invoked but seldom read, Dunn explores him in the context of the extraordinary times in which he lived, his philosophy, and his politics. By offering a detailed overview of Keynes's critique of mainstream economics and General Theory, Dunn argues that Keynes provides an enduringly valuable critique of orthodoxy. The book develops a Marxist appropriation of Keynes's insights, arguing that a Marxist analysis of unemployment, capital and the role of the state can be enriched through such a critical engagement.

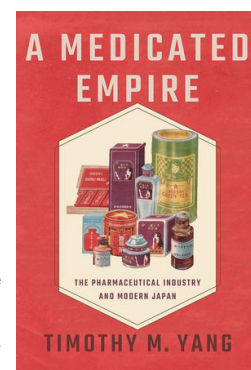

Focusing on Hoshi's connections to Japan's emerging nation-state and empire, and on the ways in which it embraced an ideology of modern medicine as a humanitarian endeavor for greater social good, Yang shows how the industry promoted a hygienic, middle-class culture that was part of Japan's national development and imperial expansion.

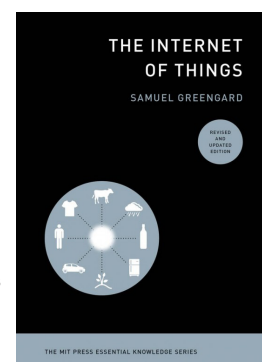

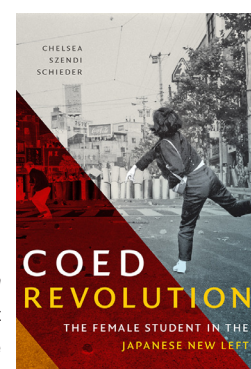

In the 1960s, a new generation of university-educated youth in Japan challenged forms of capitalism and the state. In *Coed Revolution* Chelsea Szendi Schieder recounts the crucial stories of Japanese women's participation in these protest movements led by the New Left through the early 1970s. Women were involved in contentious politics to an unprecedented degree, but they and their concerns were frequently marginalized by men in the movement and the mass media, and the movement at large is often memorialized as male and masculine. Drawing on stories of individual women, Schieder outlines how the media and other activists portrayed these women as icons of vulnerability and victims of violence, making women central to discourses about legitimate forms of postwar political expression.

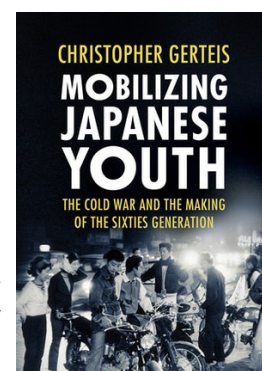

In *Mobilizing Japanese Youth*, Christopher Gerteis examines how non-state institutions in Japan - left-wing radicals and right-wing activists - attempted to mold the political consciousness of the nation's first postwar generation, which by the late 1960s were the demographic majority of voting-age adults. Gerteis argues that socially constructed aspects of class and gender preconfigured the forms of political rhetoric and social organization that both the far-right and far-left deployed to mobilize postwar, further exacerbating the levels of social and political alienation expressed by young blue- and pink-collar working men and women well into the 1970s, illustrated by high-profile acts of political violence committed by young Japanese in this era.

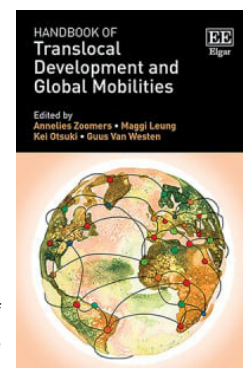

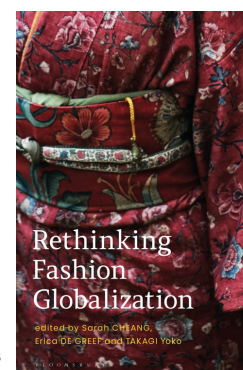

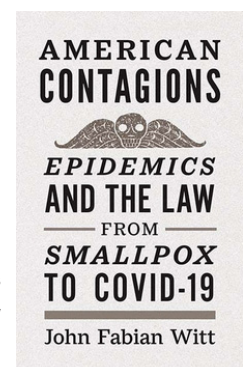

What is the role of the federal government, and what is the role of the states? Will long-standing traditions of government and law give way to the social imperatives of an epidemic? Will we let the inequities of our mixed tradition continue?

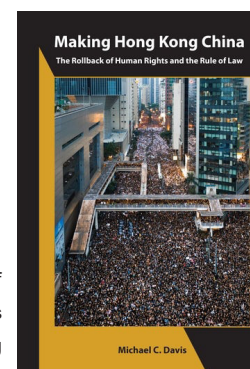

As "one country" seemed set to gobble up "two systems," the people of Hong Kong riveted the world's attention in 2019 by defiantly demanding the autonomy, rule of law and basic freedoms they were promised. In 2020, the new National Security Law imposed by Beijing aimed to snuff out such resistance. Will the Hong Kong so deeply held in the people's identity and the world's imagination be lost? Professor Michael Davis, who has taught human rights and constitutional law in this city for over three decades, and has been one of its closest observers, takes us on this constitutional journey.

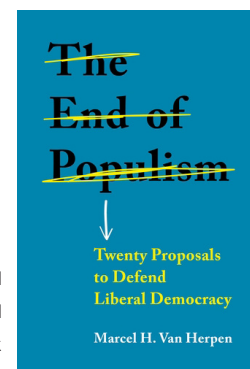

Drawing on extensive original sources, this book refutes the populist claim that democracy is a "demand side" phenomenon, and demonstrates that it is rather a "supply side" phenomenon. Marcel H. Van Herpen argues that one can have "too much democracy" and shows how methods of direct democracy, such as popular initiatives, referendums, and open primaries, which pretend "to give the power back to the people," have led to manipulation by populists and moneyed interests. Populist attacks on the judiciary, central banks, the media, and other independent agencies, instead of strengthening democracy, have rather undermined liberal democracy. The author formulates twenty original and bold proposals to bridge the gap between the people and the elites, fight corruption, improve political party funding, and initiate societal, educational, and macro-economic reforms to increase economic equality and alleviate the insecurity of the citizens.

(B)ordering Britain argues that Britain is the spoils of empire, its immigration law is colonial violence and irregular immigration is anti-colonial resistance. In announcing itself as postcolonial through immigration and nationality laws passed in the 60s, 70s and 80s, Britain cut itself off symbolically and physically from its colonies and the Commonwealth, taking with it what it had plundered. This imperial vanishing act cast Britain's colonial history into the shadows. The British Empire, about which Britons know little, can be remembered fondly as a moment of past glory, as a gift once given to the world. Meanwhile immigration laws are justified on the basis that they keep the undeserving hordes out. In fact, immigration laws are acts of colonial seizure and violence.

Since the beginning of the Meiji period when Japan evolved into a modern and powerful nation-state, ideas of empire and constitution imbued Japanese rule and progress. In *Empire and Constitution in Modern Japan*, Junji Banno expertly analyses how these conflicting concepts operated together in Japan from 1868 until 1937. By 'empire', Banno means the Japanese impetus to create its own empire; by 'constitution', he identifies Japanese efforts to create a constitutional government. In this book, Banno discusses the complicated relationship between these two concepts, ranging from incompatibility in some periods to symbiosis in others. Furthermore, understanding the complex and competing nature of these ideals, he persuasively reasons, is key to our understanding of why Japan and China went to war in 1937, leading to Pearl Harbor just four years later.

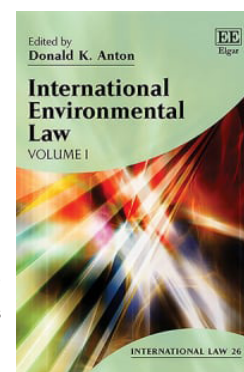

Chapters analyze both cases anchored in a particular legal system (such as anti-corruption in China) and big data law approaches relevant across multiple practice areas: including machine learning within law, legal information retrieval, natural language processing and e-discovery. From Country to Nation tracks the emergence of the modern Japanese nation in the nineteenth century through the history of some of its local aspirants. It explores how *kokugaku* (Japan studies) scholars envisioned their place within Japan and the globe, while living in a castle town and domain far north of the political capital. Gideon Fujiwara follows the story of Hirao Rosen and fellow scholars in the northeastern domain of Tsugaru. On discovering a newly "opened" Japan facing the dominant Western powers and a defeated Qing China, Rosen and other Tsugaru intellectuals embraced *kokugaku* to secure a place for their local "country" within the broader nation and to reorient their native Tsugaru within the spiritual landscape of an Imperial Japan protected by the gods. Although Rosen and his fellows celebrated the rise of Imperial Japan, their resistance to the Western influence and modernity embraced by the Meiji state ultimately resulted in their own disorientation and estrangement. By analyzing their writings - treatises, travelogues, letters, poetry, liturgies, and diaries - alongside their artwork, Fujiwara reveals how this socially diverse group of scholars experienced the Meiji Restoration from the peripheries.
