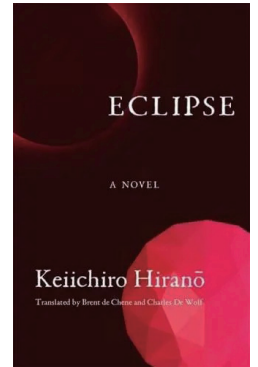

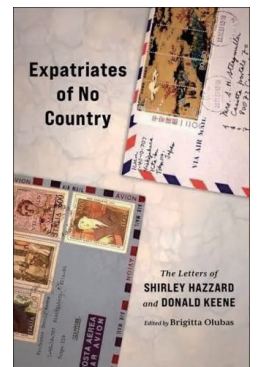

Keene, a pacifist who served as an intelligence officer in the U.S. Navy during World War II, devoted himself to the literature and culture of Japan, where he became revered. Their erudite and elegantly written letters trace the larger story of their friendship, finding striking overlaps between their distinctive worlds.

Matsuoka traces noh's connections to popular and religious dances, linked verse, and *chigo* (beautiful temple boy) culture, emphasizing performance and the body. He describes the world of noh playwright Zeami as well as his views on dramaturgy and performance - and argues that Zeami was once a *chigo*. Matsuoka shows how religious rituals and cultural forms like ecstatic dance prayer and plays about demons in hell attracted people on the margins. Such activities, Matsuoka contends, drew on the tension between wild acrobatic movement and corporeal restraint, influencing the development of noh as well as the art of flower arranging and the tea ceremony. Janet Goff's translation makes available in English a classic work of Japanese scholarship that will be invaluable to those interested in medieval Japanese culture, noh, and theatrical practice.

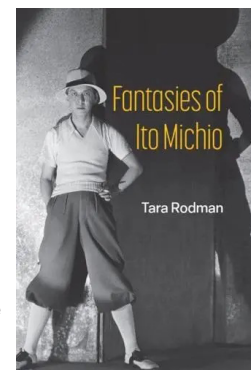

Born in Japan and trained in Germany, dancer and choreographer Ito Michio (1893-1961) achieved prominence in London before moving to the U.S. in 1916 and building a career as an internationally acclaimed artist. During World War II, Ito spent two years in the Japanese internment camps, later repatriating to Japan, where he contributed to imperial war efforts by creating propaganda performances and performing revues for the occupying Allied Forces in Tokyo. Throughout, Ito continually invented stories of voyages made, artists befriended, performances seen, and political activities carried out—stories later dismissed as false. *Fantasies of Ito Michio* argues that these invented stories, unrealized projects, and questionable political affiliations are as fundamental to Ito's career as his "real" activities, helping us understand how he sustained himself across experiences of racialization, imperialism, war, and internment.

*Eco-Disasters in Japanese Cinema* explores disaster as a powerful means for addressing environmental crises. It is the first volume dedicated to a multi-genre analysis of environmental themes in Japanese cinema. The films examined cover 1954-2020 and include documentaries, monster films, cult films, studio blockbusters, and activist cinema. The chapters highlight important moments in disaster ecocinema, introduce films not well known outside of Japan, and analyze films not previously read through an environmental lens. Chapters are organized under intersecting themes that address the slow and fast violence of local and planetary environmental destruction: toxicscapes, contaminated futures and childhoods, nuclear anxiety and violence, and ruined and apocalyptic landscapes.

Steiner reframes long-standing questions surrounding desire, art, sexual assault, and beauty in light of #MeToo. Beginning with an opera she wrote based on Chaucer's "The Wife of Bath's Tale," she presents women's sexual choices as fundamentally aesthetic in nature - expressions of their taste - and artworks as stagings of choice in courtship, coquetry, consent, marriage, and liberation. *Blessing America First* argues that under Trump, religion in U.S. foreign policy shifted from an implement of statecraft to a tool of populist political strategy. Populism constructs ideological bounds between “the people” and threatening outsiders, and embraces personalist governance while rejecting bureaucratic constraint. This domestic political logic, Buckley demonstrates, influenced foreign policy decisions and reshaped bureaucratic offices in the State Department and USAID. Populism also promoted international religious ties in a surprising range of settings, from Poland to India, Brazil to Russia. Buckley shows that the possibility of curbing these changes was limited by conditions in American democracy that predated the 2016 election, including norms of nonpartisanship among career officials, malleable legal institutions, and polarization in public opinion.

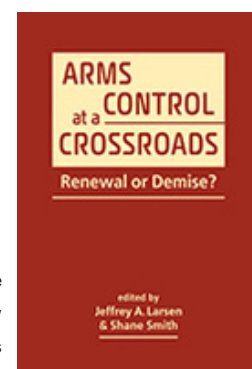

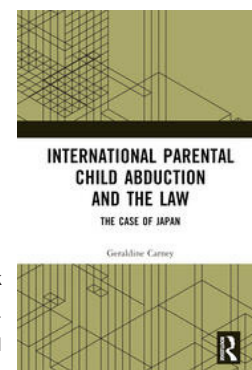

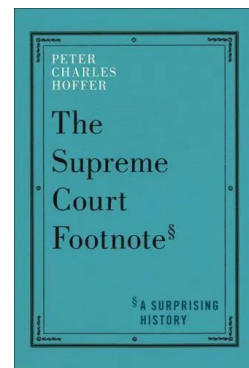

He examines the Kremlin's motives, tracing Putin's transformation from a seemingly pragmatic leader into an embittered tyrant who saw it as his historical mission to reconquer Ukraine. Kim places the war in the broader context of the Soviet Union's collapse, arguing that it represents a clash between those who reject the Soviet past - like Volodymyr Zelensky and Alexei Navalny - and those who still identify with it. He debunks the Kremlin narrative that the West instigated the conflict, and he instead identifies the root causes of the war in the legacy of Russian imperialism and Putin's dictatorial rule. At the same time, Kim is critical of the West's empty promises to Ukraine, which made the country vulnerable to a revanchist Russia.
