

Empire of Culture brings together contemporary representations of Victorian Britain to reveal how the nation's imperial past inheres in the ways post-imperial subjects commodify and consume "culture" in the late twentieth and early twenty-first centuries. The globalization of English literature, along with British forms of dress, etiquette, and dining, in the nineteenth century presumed and produced the idea that British culture is a universal standard to which everyone should aspire. Examining neo-Victorian texts and practices from Britain, the United



States, Japan, and Singapore - from A. S. Byatt's novel Possession and its Hollywood film adaptation to Japanese Lolita fashion and the *Lady Victorian* manga series - Waiyee Loh argues that the British heritage industry thrives on the persistence of this idea. Yet this industry also competes and collaborates with the US and Japanese cultural industries, as they, too, engage with the legacy of British universalism to carve out their own empires in a global creative economy.

This richly-illustrated book covers a wide range of objects associated with Mingei, from ceramics and furniture to textiles and toys, alongside a series of profiles of leading designers and makers

working in Japan today. Contributors from a variety of backgrounds explore Mingei's origins, interpretations and contemporary implications, shedding new light on the ways in which the principles of the movement remain relevant to today's personal, social and environmental concerns.

What does it take to build not only a house but a machine for amusement? In *Machine à Amuser*, Wim van den Bergh chronicles the genesis of the famous penthouse of French-born Mexican millionaire bachelor Charles de Beistegui. The penthouse was planned and constructed by Le Corbusier & Pierre Jeanneret and built on a rooftop site on the Champs-Élysées between 1929-1932. Retracing the evolution of this icon of modern architecture from the initial competition between Gabriel Guevrekian, André Lurçat, and Le Corbusier & Pierre Jeanneret up to the executed version, van den Bergh tells the story of a client's ambition to build a house devoted to entertaining on one of the most well-heeled streets of Paris.



After achieving international acclaim as a painter and designer, El Lissitzky set out in 1924 to convince the world - and himself - that he was also an architect. He did this with a project for a "horizontal skyscraper," which he gave an obscure and untranslatable name: Wolkenbügel. Eight of these buildings, perched atop slender pillars, were intended to stand at major intersections along Moscow's Boulevard Ring, integrating the flow of tramlines, subways, and elevators. In *Wolkenbügel*, Richard Anderson explores Lissitzky's translation of visual and textual media into spatial ideas and offers an in-depth study of the surviving drawings and archival artifacts related to Lissitzky's most complex architectural proposal.







Japanese Americans have long contended with settler colonization and mass criminalization by the state, most notably during the WWII era when they were forced into incarceration camps. In *Carceral Entanglements*, Wendi Yamashita asks, how do narratives of worth and success that make Japanese Americans legible to the state come to be? What are the consequences of such narratives? *Carceral Entanglements* features interviews, archival research, and texts to explore racial violence and patriotic masculinity and explain how Japanese American



history and identity are publicly memorialized. Yamashita examines museums, digital archives, pilgrimages, and student-run and performed plays to understand how Japanese Americans occupy a "contradictory location" produced by the state. She also addresses historical erasure, race relations and the struggle for redress and reparations.







Caitlin Mollica illustrates the role of political will and agency in the development of transitional justice mechanisms that are substantively inclusive of those traditionally marginalized by post-conflict institutions,
